The meeting of the Permian Basin MPO Policy Board was called to order at 3:02 p.m. by Policy Board Chair, Debi Hays. A quorum was present.

- 2. Introductions and Announcements None.
- 3. Public Comment Period None.
- 4. Approve the Policy Board Minutes from May 18, 2020
 A motion was made by Doug Provance and John Speed to approve the Policy Board Minutes from May 18, 2020. The motion passed unanimously.
- 5. Approve the March and April 2020 Billing Statements

March is the sixth billing period for fiscal year 2020; the tables below reflect the expenditures from Tasks and Subtasks as approved in the FY 2020 UPWP. During the month of March, Permian Basin MPO expended \$34,754.42 which brings the percentage of expenditures to 33.32% of the FY 2020 programmed funds. The actual balance of funds is \$760.212.88.

April is the seventh billing period for fiscal year 2020; the tables below reflect the expenditures from Tasks and Subtasks as approved in the FY 2020 UPWP. During the month of April, Permian Basin MPO expended \$33,109.51 which brings the percentage of expenditures to 37.86% of the FY 2020 programmed funds. The actual balance of funds is \$727,103.37.

A motion was made by Robin Donnelly and Jack Ladd approve the March and April Billing Statements. The motion passed unanimously.

6. Approve the FY 2021 Unified Planning Work Program

The FY 2021 Unified Transportation Work Program is the operating budget for the MPO and is required to be reviewed and approved by the Policy Board. Although some MPOs in Texas maintain a two-year budget, the Permian Basin MPO has operated on a one-year cycle since FY 2014. Beginning in FY 2020 the MPO increased its budget to \$700,000 from a previous trend of annual budgets between \$415,000 to \$450,000. The reason for the increase is that the MPO was maintaining an excess of what are known as "carry over" funds. While there will be carry over funds associated with each budget, the reduction in this resource will allow the MPO to program more funds for agency needs and planned corridor studies. As a reminder, these are federal transportation planning funds that come from USDOT through the Federal Highway Administration and the Federal Transit Administration. The majority of the funds come from the FHWA. The funds are authorized under federal law for the MPO to maintain a coordinated, continuous, and comprehensive transportation planning process within the defined area, known as the Metropolitan Area Boundary.

In FY 2020 the staff included additional funds under Task 5, Special Studies, to commence numerous studies utilizing a large portion of the carry-over funds the MPO had intentionally left unprogrammed for a few years. The FY 2021 UPWP indicates \$220,000 of available funds for corridor studies; \$35,000 has been made available for the EZ-Rider comprehensive transit study, and

The main differences between this year's proposed budget and the current budget are:

- less money on the MTP in FY 2021
- more money on the CMP congestion related topics
- \$35K that the Board agreed to contribute to EZ Rider for a comprehensive transit study
- continuation of the Bicycle/Pedestrian corridor alignment work
- commencement of studies that were discussed but not started
- creation of a Permian Basin Regional Freight Advisory Committee
- additional money on freight related topics
- continued assistance with public involvement and agency marketing
- more money on federal performance measures and targets
- assistance with Travel Demand Modeling exercises

A motion was made by John Speed and Robin Donnelly to table the numerical prioritization of the FY 2021 Unified Planning Work Program. The motion passed unanimously.

7. MPO Staff Reports

a. 90-Day Calendar

Staff included a 90-day event calendar to inform the Policy Board of upcoming events.

b. Update on calendar for TxDOT Ports-to-Plains Study

The 86th Texas legislature passed House Bill 1079 (HB 1079) relating to a study by the Texas Department of Transportation (TxDOT) of the Ports-to-Plains Corridor, including an evaluation of the feasibility of certain improvements to Interstate Highway 27 (I-27). The governor signed the bill into law on June 10, 2019.

The Bill requires a report to be delivered to the governor by January 2021. TxDOT hired a consulting team to assist with a feasibility study for an extension to the north and south of the existing portion of I-27 which connects Lubbock to Amarillo. TxDOT has managed the process of completing the study. Early on the corridor was subdivided into three subsections. The Midland Odessa area is in Segment Two which extends from south of Lubbock to Sonora (I-10).

On June 26th, the TxDOT Freight Division team led a presentation covering the results of the work completed by the Segment Two Subcommittee. Five meetings of the subcommittee were held. All three subcommittee reports were due to the Advisory Committee by June 30th. The next step in this important work is for the entire Advisory Committee to submit its final recommendations to TxDOT by October 31, 2020. The final report will be sent to the Governor and the Legislature by

January 1, 2021. A copy of the summary document submitted by the Segment Two Subcommittee was emailed to the Board the week of July 13th.

c. Update on calendar for TxDOT 24-county regional freight study

The Permian Basin Freight and Energy Sector Steering Committee held a virtual meeting on June 26th. Judge Hays chaired the meeting. The TxDOT Freight Division staff (Caroline Mays/Casey Wells) and the consultants (Paula Dowell – Cambridge Systematics) presented the draft materials for review and comment. The draft final plan and executive summary will be made available for Steering Committee review in August. It is expected that the work will be complete in August as well.
